

Filing requirements Netherlands Antilles

I Filing of application for registration

- a) name and address of applicant and of his NA trademark agent.
- b) print of mark; 15 prints for black and white; 24 prints for color.
- c) specification of color or colors of mark if applicant desires to have these colors serve as distinguishing characteristic for the mark.
- d) if applicable, specification that the trademark consists wholly or partly of the shape or form of the goods or its packaging.
- e) specification of the goods or services covered by the mark; an exact description using the terminology of the alphabetical list of the International Classification of the Nice Convention in the same order of such classification as well as a mentioning of the specific classes.
- f) if applicable, specification that it concerns a collective mark, in which case the regulations governing use and power of attorney to Netherlands Antilles trademark agent executed by applicant.
- h) proof of payment of official filing fees.
- i) if applicant invokes a right of priority, specification of his name, address, country, date and number of the application and filing on which the right of priority is based. If the applicant filing in the country of origin is not the same party as the applicant filing in the NA, then the NA-applicant must also submit such a document. Applicant must submit certified copy of documents on which his rights of priority are based.

II **Renewal**

- a) name and address of owner of the mark and of his NA trademark agent.
- b) print of mark; 15 prints for black and white; 24 prints for color.
- c) if number of goods or services for which mark is used has been limited since last publication of filing, an exact specification of the goods or services for which the mark is used, using the terminology of the alphabetical list of the International Classification of the Nice Convention, in the same order of such classification, as well as specification of the classes.
- d) power of attorney to NA trademark agent executed by applicant.

III **Search of trademark register and preliminary search as to availability of a trademark or service mark**

- a) name of address of applicant and of his NA trademark agent.
- b) print of mark and if applicable, specification of color(s) of the mark and specification that the mark consists wholly or partially of the shape of the goods or its packaging.
- c) if applicable, specification that it concerns a collective mark.
- d) power of attorney to NA trademark agent executed by proof that official fees have been paid.
- f) specify whether applicant desires that the search be conducted on an expedited basis.

IV Assignment, License, Embargo, Pledge

- a) name and address of applicant and his NA trademark agent.
- b) registration number of mark.
- c) certified copy of document evidencing assignment, license, embargo, pledge.
- d) power of attorney to NA trademark agent executed by applicant
- e) proof that applicable official fees have been paid.

V Change of address; Change of name

- a) name and address of applicant and his NA trademark agent.
- b) registration number of mark.
- c) certified copy of document evidencing change of name.
- d) specification of change of address or change of name. If applicant requesting change of address is not the same party as the one in whose name the existing registration is and if the address of such applicant is not the same as the one in the existing registration, then it is necessary to file an application for recordal of change of name or address of the mark of the registrant first.
- e) power of attorney to NA trademark agent.
- f) proof that official fees have been paid.

VI Cancellation

- a) name and address of applicant and his NA trademark agent.
- b) if applicable, certified copy of judgment or court ruling whereby cancellation of registration was decreed.
- c) power of attorney to NA trademark agent, executed by applicant.
- d) proof that official fees have been paid
